Medium Commercial Program for Grocery Businesses

Grocery, convenience and liquor stores are among the most energy intensive businesses to operate. The Cape Light Compact is offering a special program to help these stores take advantage of energy efficiency rebates and incentives worth thousands of dollars.

This is an easy path to improve your store, your operations and your sales.



The Medium Commercial Program for Grocery Businesses provides comprehensive information, energy assessments and energy efficiency incentives to assist and encourage customers to retrofit existing businesses with cost-effective energy efficient measures.

The program focus is on measures that reduce consumption of electricity and deliverable fuels. The Compact works closely with National Grid to offer efficiency services for natural gas heated facilities.

Who can Benefit?

If you are an existing grocery, convenience or liquor store and use between 100,001 and 1.5 million kWh per year, you are eligible for savings through this program.

The Compact also has programs tailored to restaurants and lodging businesses. However, any medium commercial customer who contacts the Compact for an assessment will be served, regardless of type.

How Does it Work?

Step 1: Free Energy Assessment

The program starts with a comprehensive free energy assessment. This free assessment will provide your grocery business a site-specific report of recommendations for energy savings measures. When applicable, sites will receive the following energy savings measures at no cost:

- * Efficient screw-in lamps to replace inefficient lamps
- * Aerators
- * Showerheads and spray valves

Step 2: Choose Energy Saving Measures and Incentives

From the assessment report, select the recommended measures you wish to implement based on a tiered package of energy efficiency incentives available to grocery, convenience, and liquor stores. Customers can participate in multiple tiers.
