

Cape Light Compact 2021 Email Promotion OFFICIAL RULES

MUST BE 18 YEARS OF AGE OR OLDER TO PARTICIPATE.

Sponsor: Cape Light Compact JPE (“Cape Light Compact”)

Eligibility: Cape Light Compact’s 2021 Email Sweepstakes (“Promotion”) is open to current residential electric customers within Cape Light Compact territory at the time of entry, ages 18 or older.¹ Void outside of Massachusetts and where otherwise taxed, prohibited or restricted by law. By entering this Promotion, each entrant (“Entrant”) warrants that he/she/they meets the above eligibility requirements and agrees to these Official Rules.

To Enter: The Promotion begins on Wednesday, February 24, 2021 at 9:00 a.m. Eastern Time (“ET”) and ends on March 23, 2021 at 9:00 a.m. ET (“Promotion Period”). During the Promotion Period, visit Cape Light Compact’s newsletter webpage at <https://www.capelightcompact.org/news/newsletter/> (“Website”), enter the requested information, and click “Sign up” to subscribe to the monthly newsletter. Active newsletter contacts as of March 9, 2021 at 9:00 a.m. will be eligible to win a Nest Third Generation Learning Thermostat and active newsletter contacts as of March 23, 2021 at 9:00 a.m. will be eligible to win a Mass Save® Online Store Gift Card. Active contacts include subscribed list members who have opened at least one email from a Cape Light Compact MailChimp campaign since January 1, 2019 or have joined the list after that date.

Newsletter subscriptions that are received during the Promotion Period which are fully compliant with these Official Rules are valid entries (“Valid Entries”) for the prize offered during that Promotion Period. Limit one (1) entry per Cape Light Compact residential electric account during the Promotion Period. No person may enter more than once by using different email addresses, and no email address can be used to submit more than one subscription. Entries received from any person or email address in excess of the stated limitation will be void.

In the event of a dispute as to who submitted an entry, the name of the authorized account holder associated with the email address will be deemed to be the Entrant and such Entrant must comply with these Official Rules. The authorized account holder is defined as the natural person who is assigned to the email address by an Internet access provider, online service provider, or other organization that is responsible for assigning email addresses or the domain associated with the submitted email address. Potential winners are subject to verification by use of proper identification and may be required to show proof that they are the authorized account holder.

Entries that are late, contain false information, are garbled or incomplete, are altered or otherwise irregular, are generated by script, macro, or other automated means, that have been submitted through illicit means or by any means which subvert the entry process, or that do not conform with or satisfy any or all of the conditions set out in the Official Rules will be void.

Prize: One entrant selected at random will win a Nest Third Generation Learning Thermostat, Model: T3007ES (“Prize”). One entrant selected at random will win a Mass Save® Online Store Gift Card (“Prize”). Prizes include delivery within Massachusetts. Prizes will not be shipped outside of Massachusetts. Total estimated retail value of a Nest Third Generation Learning Thermostat, Model: T3007ES is \$149.00. Total monetary value of a Mass Save® Online Store Gift Card is \$150.00.

Selection of Winner/Winner Notification/Odds of Winning: One winner will be chosen at random at the conclusion of the first phase of the Promotion on March 9, 2021 after 9:00 am ET by Cape Light Compact. A second winner will be chosen at random at the conclusion of the second phase of the Promotion on March 23, 2021 after 9:00 am ET by Cape Light Compact. A total of two winners will be selected for this Promotion. Notwithstanding the foregoing, selecting the winners is a manual process, and Cape Light Compact reserves the right to exercise its own discretion at any point in the winner selection process.

The potential winners will be sent an e-mail and will be required to provide his/her/their full name, address, city, state, zip code, date of birth, and phone number (including area code) and to complete any additional documents requested by Cape Light Compact, if any, to claim his/her/their prize. The potential winners may be required to sign and return an Affidavit of Eligibility and receipt. Each potential winner will have five (5) business days from e-mail notification to provide required information or the Prize may be forfeited and awarded to an alternate winner from among all eligible remaining entries received. E-mail notification shall be deemed to have occurred on the date of Cape Light Compact’s or Cape Light Compact’s designees’ first attempt to make e-mail contact with a potential winner.

If a potential winner is found to be ineligible for any reason, an alternate winner may be selected, at Cape Light Compact’s sole discretion. If prize e-mail or Prize is returned as undeliverable it will result in disqualification, and the Prize may be awarded to an alternate winner. Any non-response by potential winner, or Cape Light Compact’s failure to receive a response from a potential winner within the prescribed five (5) business day period will result in disqualification and the selection of an alternate winner, at Cape Light Compact’s sole discretion and time permitting.

In the event Cape Light Compact is unable to contact a potential winner, or if a potential winner is non-compliant with these Official Rules, the potential winner will be disqualified and an alternate winner may be selected. Cape Light Compact is not responsible for unsuccessful efforts to notify the potential winner. The Prize will be delivered to each winning Entrant’s place of residence based on the information provided by the Entrant. Prizes will only be delivered to addresses within Cape Light Compact territory. The prize will be shipped within ten (10) business days after the Entrant completes all Promotion requirements and is confirmed as a valid electric customer within Cape Light Compact territory.

One entrant will be chosen to receive a Nest Third Generation Learning Thermostat at the conclusion of the first phase of the Promotion, and one entrant will be chosen to receive a Mass Save® Online Store Gift Card at the conclusion of the second phase of the Promotion.
